

The CPET Helpline service has been set up to help the public sector purchase legal and sustainable timber, as required by the UK Government. This service is run by ProForest and is available free of charge to the following public sector groups and their suppliers:

- Central government departments
- Executive agencies
- Local government
- Non-departmental public bodies
- Direct suppliers to central and local government

The UK Government which is funding the service, restricts the use of the CPET Helpline service to the above categories. Private companies who are not eligible to use the free CPET Helpline can get advice from a range of other sources including those set out below:
